

Sales Contract for the Right to Control the Appearance of Luciana Janaqui

This contract is made and entered into by and between Luciana Janaqui (herein 'Seller') and Mr. K (herein 'Purchaser') as follows concerning the sale of the right to control the appearance of Luciana Janaqui.

Article 1 (Definitions)

Purchaser shall be entitled to customize Seller's appearance as he likes.
This contract involves no sexual services.

Article 2 (Acknowledgements)

Seller hereby pledges to continuously make her appearance meet Purchaser's specifications to a maximum extent.
Purchaser must provide sufficient and timely financial support to Seller in order to make it realizable.

Article 3 (Payments)

Purchaser must pay a monthly fee of 200,000 Japanese Yen to Seller for keeping the right.
Seller shall charge Purchaser for each related expense by submitting its receipt to him.

Article 4 (Obligations)

Seller must always style herself with the clothes, the haircut, and the makeup specified by Purchaser as long as this contract is valid.
Purchaser must purchase all the monthly issues of major female fashion magazines available in Japan and shall discuss with Seller the future direction of her style.

Seller must have monthly meetings with the stylist designated by Purchaser to have her hair cared.

The main references include the followings.

- Outfits: COCO DEAL, SNIDEL, Apuweiser-riche, Pinky & Diane, Strawberry Fields, Andemiu, Rirandture, etc.
 - Magazines for outfits: sweet, Oggi, etc.
 - Shoes: Heels more than 7cm high by DIANA, etc.
 - Homewear: gelato pique.
 - Underwear: Salute by WACOAL.
 - Skincare: SK2 by Shiseido.
 - Makeup: Crystalline and feminine finish with the blue base by IPSA, any cushion foundation by Dior, the blue pink blush by Clinique, and any mascara by Lancôme. No brands are specified for lipsticks, but their colors should be beige- or pink-toned.
- Seller must retain her body and face good enough to meet the customization by Purchaser. Purchaser may terminate this contract when he decides that Seller is in an aesthetically insufficient condition to demonstrate the style that he requests.
Purchaser must retain his economic power strong enough to enable Seller to execute his requests.
Seller may terminate this contract when she decides that Purchaser is in a financially insufficient condition.

Article 5 (Prohibitions)

Seller must not have or wear the followings whenever she is with Purchaser.

- A sweatshirt and/or sweatpants.
 - Unbrushed hair.
 - No makeup.
 - Lipstick whose color is extremely red or non-standard such as purple.
 - Pants whose style is not neatly feminine.
 - Girlish clothes such as those with frills.
 - Shoes other than heels more than 7cm high such as sneakers.
- Purchaser must not order Seller to change anything other than her appearance, such as her mindset or lifestyle.

Article 6 (Assignments)

Seller and Purchaser are not entitled to transfer or assign any of their rights and obligations stipulated by this contract to a third party.

Article 7 (Consultations)

Seller and Purchaser, when disputes or questions arise as to items not stipulated in this contract or interpretation of its articles, shall resolve the problems through discussions in the good faith between them.

The parties shall rely solely on the language of this contract and shall not use any other material in its interpretation.

Seller (Luciana Janaqui) hereby acknowledges Purchaser () as the one who has the right to decide her appearance, and Purchaser must responsibly provide Seller with appropriate instructions and necessary financial support.

In witness whereof, the parties hereto have executed this contract in duplicate by placing their signatures thereon, and each party shall keep one copy of the originals.
